Texting, Talking & Driving: Are You At Risk?

Look right or left anytime during your morning commute tomorrow and nearly every other driver will be on a cell phone... talking, texting, tweeting or maybe even surfing the Web for the score of last night's big game. Staying connected has become the imperative in American life, even when hurtling down the highway at 65 mph in a one-ton machine. But hold onto your "LOLs" and "CUL8Rs," because there's a growing movement afoot to unplug those cellular distractions while driving. You should know the latest on safety, cell phones and the road.

The National Safety Council estimates that 28 percent of all road accidents are attributable to cell phone use each year, or 1.4 million crashes. Other studies suggest:

- Drivers on the phone are four times more likely to crash
- You drive like you are legally drunk (blood alcohol level of .08) while on a cell phone
- Hands-free devices don't solve the problem because the real danger is concentrating on the cell phone conversation

State officials have responded by prohibiting texting and driving in 19 states, hand-held cell phones in five states, and are proposing

tougher, new laws in 26 states.

Yet, most Americans aren't hitting the off button when they jump in the car. Millions of people continue to talk and drive, an estimated 81 percent of all cell phone owners.

The American Automobile Association recommends you not use your phone while driving. Be safe, stay alert, and reduce your risk.

SAFETY WARNINGS

Defective Hip Implant Recall: YOU MAY BE ENTITLED TO COMPENSATION

Hip implants manufactured by DePuy Orthopaedics, Wright Medical Technologies and Zimmer Holdings are being recalled. They are all considered metal-on-metal devices, where a metal cup socket is placed on the hip and is attached to a metal ball fitting that is attached to the thigh bone.

Initially, implant patients noticed extreme pain, infections and their hip locking up due to the devices breaking, splintering and fracturing. Another side effect that has come to light over the past year is the device grinding, and tiny metal shavings entering a patient's bloodstream. Early studies have linked this metal poisoning to a variety of serious health problems. Most notably, a few weeks ago, a study was released linking chromium poisoning

to melanoma, a form of skin cancer.

In light of these developments, some surgeons are now taking the position that all DePuy ASR hips need to be removed, even if the patient is not experiencing physical side effects. **Therefore, the patient need not feel pain or have physical problems to make a claim.**
