Dead Red Light Law

ABATE of Wisconsin asked the state's legislators to amend the statutes regarding stop lights. Many rural stop lights remain red until a vehicle approaches and is recognized by sensors, but motorcycles often do not activate these sensors. In 2006, the law was changed to allow motorcyclists to proceed after waiting 45 seconds if the sensor was not activated to change the light, as long as they did not infringe the right of way of other vehicles or pedestrians in a walkway. Attorney Michael Hupy advised and assisted ABATE of Wisconsin in passing this legislation and testified for its passage at the Wisconsin legislature.

Though there are several differences, A.B.A.T.E. of Illinois was able to convince its legislature to pass a similar law with no actual time limit but rather stating that a motorcyclist must wait a "reasonable" amount of time before proceeding through a red light. However, this ambiguous language could lead to problems. What is reasonable? Is a biker's idea of reasonable the same as the police officer observing him at the light?

Illinois Governor Pat Quinn issued an amendatory veto when the bill first passed both houses of the legislature back in May 2011, instead asking that motorcyclists be required to wait no less than 120 seconds before proceeding. The veto was defeated by a three-fifths majority vote of both houses, and the law became effective on January 1, 2012. Before the law could take effect, Senator Gary Forby filed a new bill, SB2528, calling for a 120-second time requirement, which passed the Illinois Senate on March 22, 2012 and has been sent to the Assembly and Rules Committee. As of this writing, it is unknown if the bill moved up for a vote in the Assembly.

Although motorcyclists in Illinois can proceed on red after waiting a reasonable amount of time, or after 120 seconds if SB2528 passes into law, this is not the case in Chicago. Cities with populations exceeding two million are excluded from the law.

Attorney Hupy wrote to the governor of Illinois and state legislators explaining the law in Wisconsin and urging them to adopt a more reasonable time requirement like Wisconsin's 45-second rule. Hupy and Abraham, S.C. represents hundreds of injured bikers every year, and Attorney Hupy is unaware of a biker who's been injured while turning left through a red light and believes 40-45 seconds is an adequate amount of time to wait.

Hupy and Korb Beat State Farm

A motorcyclist stopped suddenly to avoid hitting the car in front of him after it stopped to avoid hitting a ladder that had fallen off of a van. State Farm, the biker's Uninsured Motorist insurance carrier, claimed the biker was 100% at fault for his own injuries because he was following too closely behind the car, which was able to avoid the van's ladder.

Hupy and Abraham, S.C. lawyers Michael Hupy and Todd Korb argued that the motorcyclist was confronted with an emergency. The insurance company offered to pay \$1,000 at mediation and the case went to trial. The jury agreed with our client, found the truck driver 100% at fault and awarded our client \$81,000. Choose a Lawyer With Great Caution - Marketing Schemes Aimed At You

Ever since lawyers have been allowed to advertise, finding a good lawyer amidst all of the hype and promises has been difficult. I have written articles entitled "How to Find a Good Personal Injury Lawyer" and "Throw Away Mail from Lawyers" to warn people about television advertising and the mail they receive from lawyers after an accident and how to go about finding a good lawyer.

Don't misunderstand; many good lawyers, including our law firm, advertise. Attorney Ben Glass wrote an article entitled "The Shocking Truth about Lawyer Advertising" which you can see at http://www.vamedmal.com/lawyer-advertising.cfm

Some advertising schemes tested the boundaries. Two Milwaukee area firms paid to use the name "Hupy" on an internet search engine sponsored site. When unsuspecting web surfers clicked on the name Hupy on one link, they were directed to another law firm's home page. I will discuss some of the things I have seen both recently and in the past, though I don't know if they will have continued into the future up to the time you read this.

First, lawyers who have had little or no experience trying personal injury cases can send you letters after you have been involved in an accident soliciting your business. Before hiring a lawyer, ask how much experience he or she has had trying personal injury cases.

Second, there are lawyers who have had serious legal problems yet remain active in their firms. One lawyer went to federal prison for defrauding hundreds of his personal injury clients and was released several years ago. Despite now having a prison record he got his license back several years ago after a one year suspension. Another lawyer, at the time of this writing, faces possible license revocation proceedings after a five-and-a-half-year investigation. Regardless of these events, as of May, 2012, his firm is still sending direct mail advertising to unsuspecting accident victims and advertising on television. Before hiring a lawyer, research their past to see if they can truly be as trusted as they claim.

Lawyer advertising is getting so out of hand that lawyers are now selling franchises to use fancy names and teach other lawyers how to target injured bikers. This is an example: A lawyer in a western state sells a franchise to a lawyer with an office in a Midwestern state to use a fancy name in yet a third state. The lawyer who

sold the franchise, in an interview, said that you don't have to know a Honda from a Harley-Davidson to buy a franchise and our lawyers in the Midwestern state are doing quite well and bought a motorcycle and got a license for credibility purposes.

One lawyer in Wisconsin sends accident victims a two-page letter explaining all the reasons you should hire that lawyer. Buried in the fourth paragraph on the second page is a statement that indicates if you call the lawyer's phone number you are consenting to have your case also worked on from the beginning by another, but unnamed, law firm. Where does it end?

Lastly, one of the worst things we've seen are lawyers who demand exclusive advertising rights with rights organizations. Really? A lawyer working with a rights organization and demanding suppression of information and free speech and of the free enterprise system itself? If that wasn't bad enough, one of these lawyers has been known to send clients to a lawyer with a third-rate rating in Martindale Hubbell. Before hiring a lawyer, you may see referral services, even from other states, and then wonder how good the lawyer is that you've been referred to.

Be careful out there – both on the road and when hiring a lawyer.

Injured Biker Receives \$1.25 Million

On August 6, 2008, a client of Attorney Jason F. Abraham was operating her 2008 motorcycle in West Bend, Wisconsin. Suddenly, and without warning, an accident ensued where a vehicle rearended a GMC van, pushing it into the path of the oncoming motorcycle. As a result, a catastrophic collision occurred between the motorcycle and the van.

The client was immediately rushed to Froedtert Hospital based on the serious nature of her injuries. Upon presentation to the emergency room, the client was hypotensive and required an immediate blood transfusion. As a result of the accident, the client sustained a left thigh wound, sacral fractures, left femur fracture, left tibial plateau fracture, a

pelvic fracture and a dislocated elbow. Thankfully, the trauma team at Froedtert Hospital was able to piece the client back together. However, after two years of extensive treatment, surgeries, physical therapy and rehabilitation, the client was still left with serious personal injuries. Given the permanent restrictions placed on the client, there was also going to be an impact on the client's future employment.

Attorney Jason F. Abraham immediately began working on this case when it came into the firm. The insurance company initially would not disclose the amount of insurance available and, as a result, a lawsuit had to be filed. Upon filing the lawsuit, Attorney Abraham learned that there was \$1.25 million of insurance

available from the at-fault driver's insurance company. The client had approximately \$425,000.00 in medical expenses as a result of the accident. For months, the insurance company failed to offer all of the available insurance. Attorney Abraham continued to say no to any offer that was made under the policy limits. After depositions were taken and Attorney Abraham continued to turn down all offers under the policy limits, the insurance company finally relented and paid the \$1.25 million.

The client was thrilled with the result. Attorney Abraham was also able to get the client's health insurance to reduce its lien to put more money in his client's pocket.

Exclusive Business Practices Smack of Illegal Monopolies

Libertarian writer and speaker Tim Nerenz posts a weekly commentary on a variety of subjects, entitled "Moment of Clarity." Recently, he wrote about monopolies and why they are illegal. Interestingly, he points out that the biggest monopoly around is the government. According to Nerenz, in the absence of competition, the monopoly ceases to serve any interest but

its own. That sounds like government to me. We trust the government to regulate, yet government workers are "perhaps the least qualified to regulate a private economy," says Nerenz.

Another dangerous situation is exclusive advertising. This practice conjures up the premise of a monopoly. Free enterprise

is compromised by practices like "exclusives" and, without competition, the holder of the exclusive rights serves only its own interest. As Nerenz so eloquently states, "It's neither the sheriff nor the priest that keeps the first auto mechanic honest in a small town; it's the second mechanic."

Three More Great Results For Hupy and Abraham, S.C. Biker Clients

Attorney Todd Korb continues to achieve great results for his clients. Recently, he settled a case that involved a motorcycle rider who was following a truck with a boat on a trailer in a residential neighborhood. The truck moved to the right shoulder and almost came to a complete stop, then turned left abruptly without signaling. Our client thought the truck was coming to a stop and proceeded to pass on the left when the truck and trailer turned into his path. Our client sustained a shoulder injury that required surgery. The insurance company for the truck driver only offered \$5,000 because it claimed the biker's negligence was greater than its insured's. Attorney Korb filed suit and obtained a \$42,500 settlement.

In another case, a motorcyclist was riding in Walworth County, Wisconsin when she was struck by a minivan. Although she was able to keep her bike upright, she suffered soft tissue injuries. Before this

accident, she had a history of chiropractic visits. Her chiropractor testified that the contact from the minivan exacerbated her condition, and she would need about 25% more treatments for the rest of her life, which she would not have needed otherwise. The defense paid for an orthopedic surgeon to testify at court in an effort to dispute the damages. The insurance company also disputed the liability of its insured and offered \$8,500 to settle the case. Attorney Korb filed suit, the jury found the minivan driver 100% at fault, and it awarded our client \$75,600, 8.9 times more than the defendant's offer.

This third case illustrates why the Truth in Auto Insurance law that passed in Wisconsin in 2009 was so important for everyone and especially bikers.

In 2010, during the annual Sturgis Rally in South Dakota, our clients were riding a motorcycle on U.S. Highway 14A near

Deadwood. A Chevrolet Suburban pulled out from a resort while attempting to cross the highway, causing the motorcycle to impact the driver's side of the SUV. The driver of the cycle received fatal injuries from the impact and the passenger had severe fractures of the leg, pelvis and ribs.

Because of the Truth in Auto Insurance law passed in 2009, Attorney Korb was able to recover a \$100,000 policy limit from the defendant's insurance in addition to stacking three of our client's underinsured policies, for a total of \$400,000. Under the current Wisconsin insurance law passed shortly after this accident, our client would have been limited to the \$100,000 from the defendant. Attorney Korb was also able to get the health insurance provider to waive a \$300,000 lien in the case.

To Plead or Not to Plead, That Is the Question

Bad Legal Advice Leads to Reversal

On March 21, 2012, the U.S. Supreme Court ruled that defendants who reject or pass up plea bargains due to their lawyers providing ineffective counsel may have their harsher sentences overturned. The Court was ruling on two cases when it rendered its 5 to 4 majority decision.

Scholars claim that the Court's decision in these two cases constitutes the "greatest revolution in criminal justice" since indigents were afforded the right to counsel in 1963.

Justice Anthony M. Kennedy, who wrote both decisions, said, "Criminal justice today is for the most part a system of pleas, not a system of trials. Ninety-seven percent of federal convictions and ninety-four percent of state convictions are the result of guilty pleas."

At the root of the problem is bad legal advice leading to defendants rejecting favorable plea offers or, in a worse case scenario, lawyers not informing their client that a deal is on the table. The Supreme Court has established that defendants are entitled to new trials if it can be shown that bad advice or incompetent representation caused a defendant to give up the right to trial by accepting a guilty plea that, in turn, resulted in a stiffer penalty than that offered in the plea bargain.

In one of the two cases decided by the high court, a defendant rejected a plea bargain based on bad advice from his attorney that called for a sentence of four to seven years. He was convicted and is serving 15-30 years.
