**\$2,000,000 for Passenger Rear-Ended by Semi**

Our client was a passenger in a vehicle that was rear-ended by a vehicle which had been rear-ended by a semi. His neck arteries were damaged, which required surgery. He suffered a stroke and multiple fractures in his spine, as well as a chipped hip bone. While the client had a good recovery, he suffered years of lost wages. Attorney Todd Korb reached a settlement of \$2,000,000.

**\$120,000 for Pedestrian Hit in Grocery Store Parking Lot**

Our client was a pedestrian walking across the grocery store parking lot when another shopper failed to see him and put her vehicle in reverse. He jumped out of the way, tripped, fell, and ultimately suffered a neck fracture which had to be surgically repaired. Attorney Eric Schade was able to resolve his claims with the insurance company for \$120,000 without having to file a lawsuit.

**\$450,000+ In Day Care Negligence Case**

Our client, an infant at a Madison area daycare, sustained a head injury while under the care of the facility. According to the daycare provider, the staff did nothing negligent; and the child hit his head on a hard object. The child was unresponsive. The daycare provider has been charged criminally regarding the accident and her license has been revoked. Although this is an ongoing law enforcement investigation with the Dane County Sheriff's Office, Hupy and Abraham Attorney Todd Korb was able to get a \$462,500 settlement without having to file suit.
