# \$245,000 for Injured Driver with Multiple Fractures

Our 68-year-old client was in the hospital for seven days following an accident with a driver who ran a flashing red traffic signal. His injuries included multiple rib fractures and a fractured pelvis. Over the next several months, he incurred over \$82,000 in medical bills.
