After Candid Admission, Cyclist Gets \$395,000

Our client was walking his bicycle across the street on a rural road in McHenry County, Illinois, when he was struck from behind by a motorist.

He sustained injuries to both his legs, shoulder and head and required multiple surgeries. The insurance company denied the claim completely because our client admitted he had been drinking. Attorney Vito Manicioto took the case to mediation and obtained a \$395,000 settlement.

Tragic Motorcycle Accident Results in \$1,350,000 Settlement

In May 2017, Attorney Jason F. Abraham's client was a passenger on a motorcycle. The driver began to operate the motorcycle at an excessive rate of speed approaching an intersection. An SUV attempted to make a left turn in front of the motorcycle, which resulted in a horrific crash.

The driver of the motorcycle was killed and our client suffered catastrophic injuries. Attorney Abraham hired experts and completed intensive negotiations, which led to both the SUV driver's and the motorcycle operator's insurance companies to pay their policy limits. Attorney Abraham obtained a \$1,350,000 settlement.

Travel Smart: Many people decide to travel by car this time of year. Compared to any other mode of transportation, the highest fatality rate occurs by automobile. Make sure every passenger is buckled up when driving, and keep an emergency kit in the vehicle. Put cell phones away, because one-quarter of crashes are caused by distracted drivers. Plus, be ready for heavy snow and traffic.

Beware of Fire: According to the National Fire Protection Association, thousands of deaths annually are caused by burns, fires and other related injuries. Candle use tends to increase this time of year, and adding combustible decorations to the mix is a risk for fire. Don't burn candles near flammable items, and don't burn decorations or wreathes in the fireplace.

Turkey fryers are also a hazard this time of year. If you decide to fry a turkey at home, keep the fryer at least 10 feet away from the house and keep all children away. Find flat ground and have a fire extinguisher ready at all times. Be cautious of the fryer lid and its handle as they can become too hot and cause burns.

Decorate with Care: Putting up decorations is a great way to get into the holiday spirit, but thousands of injuries are associated with careless actions. Hanging lights is one of the most popular parts of decorating, so make sure there are no loose connections, exposed or frayed wires or broken sockets. Double-check that walking paths are cleared so others don't trip on decorations, toys, wrapping paper and the like.

Give Gifts Safely: Giving presents is a staple of the holidays. It is important to keep the age of the recipient in mind when making selections. For infants and children, avoid toys with small parts and be sure to check if any toys have been recalled. When purchasing for older adults, pick something that isn't heavy or difficult to handle.
