## CASE RESULTS

### \$4.25 Million for Rider

Ray Snyder started his motorcycle and his day like most others in August 2016. He left his Iowa home to visit his wife at her job in Rock Island, Illinois. In an instant, his life was dramatically changed.

He was headed eastbound when a work truck headed southbound disobeyed a stop sign. To avoid a head-on collision, our client swerved. He lost control of his motorcycle and was thrown into a stopped vehicle. His injuries were catastrophic. He had 27 fractures including 5 skull fractures.

While still hospitalized, our client's wife contacted Hupy and Abraham, S.C., the only law firm she would consider, knowing our reputation, and seeing our work and involvement in the community. The firm immediately began to help them navigate the difficult road to recovery. Over the next year and a half, Hupy and Abraham, S.C. built a case for our client and eventually forced the insurance company to agree to pay \$4.25 million to settle the claim without filing a lawsuit.

### T-Boned Client Gets \$200,000

Our client was T-boned at an intersection by an inattentive driver and experienced a significant neck injury. A CT scan and MRI revealed the impact caused a spinal injury, the treatment of which normally would require hardware surgically implanted to strengthen the spine. Our client is allergic to the components in that hardware, so the surgery was postponed until alternative hardware could be developed.

Despite such a significant injury to our client's spine, the insurance companies claimed a previous neck injury absolved them from tendering policy limits. After months of negotiation, Hupy and Abraham, S.C. obtained \$100,000 in policy limits from the at-fault driver's insurance company and an additional \$100,000 from our client's underinsured motorist policy. Hupy and Abraham, S.C. did not allow our client to be pushed around by the insurance companies' tactics.

## YOU SHOULD KNOW

### Celebrate Awareness of Motorcycles, Bicycles During May

May is National Bike Month and Motorcycle Awareness Month. Each spring, restless cyclists and riders are finally able to resume their rides throughout the state. Other motorists need to be aware of the dangers these riders face.

**When bikes and motorcycles return, drivers must take some safety precautions into consideration as they share the roads:**

1. Drivers should slow down when approaching a bicycle. A fast-moving car or unexpected opening of a door can cause a bicyclist to swerve toward traffic.
2. Do not honk at a bicyclist, as it may surprise them. Leave at least 3 feet when passing a bicycle.
3. Obey the speed limit. Slow down if necessary due to road conditions.
4. Yield to bicycles and motorcycles like any other vehicles to avoid a collision.
5. When opening a car door, try to open the driver's side with your right hand. This allows you to look for an oncoming bicycle before opening the door.

**If you're a bicyclist, here's how you can stay safer during your travels:**

1. Ride with traffic in the same direction.
2. Tuck and tie your shoelaces so they do not get tangled in your bike chain.
3. Plan your route ahead of time. Try to choose routes that have less traffic and slower speeds.
4. Assume drivers do not see you.
5. Learn and use proper hand signals.
6. Look for hazards or dangerous situations to avoid that may cause you to fall, such as rocks, potholes, grates and tracks.
7. Watch for pedestrians and make sure to announce if you have to pass by them, or consider using a bell.
8. Have lights on the front and back of your bike that flash at night and reflectors in the wheels.
9. Wear reflective clothing.

**Here are some tips to help keep motorcyclists safe while you're behind the wheel:**

1. When turning left, make sure there is enough time and space for a rider to safely pass you before proceeding.
2. Always double-check your blind spots when switching lanes and entering or exiting the freeway.
3. Make sure all mirrors are in their proper placements and use them as needed.
4. Do not follow a motorcycle too closely. Make sure enough room is available for your vehicle to stop completely to avoid a crash.
5. Assess your surroundings. Don't rush when crossing intersections or entering from a driveway or parking lot. Give yourself time to look for riders.
