## CASE RESULTS

### \$4.9 Million Settlement for Motorcyclist Hit by School Bus

A Hupy and Abraham, S.C. client secured a \$4.9 million settlement after a school bus ran a stop sign and struck his motorcycle, causing severe, life-altering injuries. Even with clear video evidence and the driver's guilty plea, the school district initially denied any responsibility.

Attorney Vito Manicioto and our legal team built a compelling case through expert analysis, accident reconstruction and detailed 3-D medical modeling. After nearly two years of litigation, our team secured a \$4.9 million settlement.

### Clients Recover \$1.6 Million After Apartment Fire

A grandmother and her young granddaughter suffered devastating injuries in an apartment fire. During mediation, the insurance company offered only \$250,000, claiming they lacked prior notice of faulty smoke detectors and relying on a recent city "inspection."

Attorney Todd Korb challenged those assertions and successfully secured \$1.6 million for the family.

### \$1 Million for Client Hit by Drunk Driver

Our client was a passenger in a vehicle struck head-on by a drunk driver who crossed the centerline. The insurance company attempted to deny coverage under its uninsured motorist policy.

Following mediation, Attorney Todd Korb persuaded the insurer to reverse its position and tender its full \$1 million policy limits.
