\$110,000 for Injured Volleyball Coach

Our lowa client suffered a left rotator cuff tear that required surgery after being hit by a driver who ran a red light and struck her head-on. She was a very active individual who coached volleyball and worked as a personal trainer. But after the accident, her injuries made these activities very difficult.

Though the defendant's insurance company offered its policy limits of \$50,000, the client's insurance company offered an unacceptably low amount to settle her underinsured motorist claim.

Hupy and Abraham, S.C. was able to more than double the initial offer from the client's underinsured motorist carrier without having to go to trial, resulting in a total settlement of \$110,000.

\$130,000 for Client Who Fell at Grocery Store

As our client was shopping at an Illinois grocery store, she tripped over loose carpeting as she exited the restroom. Two days later, she was examined for shoulder and hand pain. All imaging was negative, and she was referred to physical therapy.

After five visits to physical therapy, she still had pain. Four months later, an MRI was ordered and a small tear was discovered in her right shoulder.

The grocer's in-house legal counsel asked Hupy and Abraham, S.C. to explain why the grocer was responsible for the injury. A complaint was drafted and emailed, outlining the theory of the case.

Without filing a lawsuit, the case was settled for \$130,000.

\$175,000 for Injured Biker after Insurance Company Denied Claim

On a spring day, our client was driving his motorcycle in Wisconsin when an automobile turned off the highway onto a road leading to a campsite. As our client approached the car, it suddenly backed out of the roadway, pinning his leg against his motorcycle and breaking it.

The insurer of the automobile denied the case, claiming our client simply drove into the rear of her car. Our client made a good recovery from his injuries but was off work for about six months, forcing him to file a lawsuit against the other driver.

After a minimal offer was made at mediation, Hupy and Abraham, S.C. was able to get the insurance companies involved to set the damages in the case at \$175,000 in order to have a trial to determine who was at fault.

The county jury returned a verdict in favor of our client, placing all responsibility on the other driver. An award was issued for the entire, previously-agreed-upon amount of \$175,000.
