# Top 3 "Must-Ride" Motorcycle Routes in the U.S.

Across the country, there are many amazing motorcycle routes that riders should experience during their lifetimes. Here are our top three picks:

- 1. Tail of the Dragon This widely popular route is on the North Carolina/ Tennessee border along the Deal's Gap on US 129. Many motorcyclists test their skills on this ride that features over 300 challenging curves throughout its 11 miles.
- 2. Pacific Coast Highway (PCH) The PCH follows the Pacific Ocean shoreline extending from Oregon down to Southern California. One of the most popular sections of the ride is Big Sur along California's central coast. This area features 120 miles of exhilarating cliff-hugging turns, as well as amazing views of the ocean,

redwood trees and occasional encounters with wildlife.

3. Beartooth Highway - This 68-mile route starts at Red Lodge, Montana and continues up through Wyoming's Beartooth Pass, which reaches an elevation of nearly 11 thousand feet. With the amazing scenery in two national forests and exciting hairpin turns, you don't want to miss this great ride. However, please note that this route is often closed from October to May due to snow.

## Injured Rider Receives \$2,000,000 Settlement Without Filing a Lawsuit

Our client was riding his motorcycle on a clear summer afternoon when he slowed down to make a right turn. As he decelerated, he was rear-ended by a motorist who was following too closely. This knocked our client over and pinned his leg against the ground, resulting in a puncture wound, two toe fractures and a broken ankle.

This accident left the rider with \$600,000 in medical bills and \$80,000 in wage loss, despite him being without fault. He knew he needed an attorney to get this situation sorted out and turned to Hupy and Abraham, S.C.. Attorney Todd Korb settled the case out of court for \$2,000,000 and our client was left with no permanent injuries or disabilities.

# Full Policy Limits of \$100,000 for Injured Motorcycle **Passenger**

Our client was a passenger on a motorcycle that was in an accident with an uninsured vehicle. She suffered a serious knee injury in the crash.

Her insurance company offered \$35,000 which was rejected by Hupy and Abraham, S.C.. A lawsuit was filed by Attorney Robert Domol and the insurance company offered the full \$100,000 policy limits.

# Insurance Denies Claim for Injured Rider, Hupy and Abraham, S.C. Wins \$175,000 Award

On a spring day, our client was driving his motorcycle near Elkhart Lake, Wisconsin when an automobile turned off the highway onto a road leading to a campsite. As our client approached the car, it suddenly backed out of the roadway, pinning his leg against his motorcycle and breaking it.

The insurer of the automobile denied the case, claiming our client simply drove into the rear of her car. Our client made a good recovery from his injuries but was off work for about six months, forcing him to file a lawsuit against the other driver.

After a minimal offer was made at mediation, Attorney James Shilobrit was able to get the insurance companies to agree to damages in the case at \$175,000 in order to have a trial to determine who was at fault.

On November 12, 2019, a Sheboygan County jury returned a verdict in favor of our client, placing all responsibility on the other driver. An award was issued for the entire, previouslyagreed-upon amount of \$175,000.

## \$2 Million Settlement **Just Five Months** After Crash

On a dark December morning in rural Wisconsin, life changed instantly for our client, a home health worker. She was driving to see a patient when she was broadsided by a skid steer from a dairy farm that was attempting to cross the road. Our client didn't see the skid steer until the last moment because it didn't have lights or reflective tape that was visible to approaching traffic. At the time of the impact, she was traveling about 50 miles per hour and the resulting crash was devastating, totaling her car and leaving her with significant injuries.

An ambulance ride to a local hospital was followed by a helicopter ride to Froedtert Hospital in Milwaukee. Surgery was immediately scheduled because our client sustained a ruptured aorta in the crash. Later. she returned to surgeries on her neck and lower leg to repair various injuries. After a lengthy hospital stay, our client returned home and has made a rapid recovery, hoping to return to work soon.

Following the crash, our client's husband made the call to Hupy and Abraham, S.C.. Firm Partner Chad Kreblin immediately started working on the case. After several weeks of serious negotiations, Attorney Kreblin was able to recover \$2 million for our client.

## **10 Weird Motorcycle Laws**

Wherever you go in these 50 states, you are bound to find a strange law on the books that makes you wonder how it got there and who actually follows it. Here are 10 motorcycle laws, some serious, some silly, but all of them are weird!

- 1. Don't Run Out of Gas: In Youngstown, Ohio it is illegal to run out of gas. Good advice, but it seems unlikely that anyone would run out on purpose.
- 2. No Dirty Tires: In Minnesota, a motorcycle with dirty tires is considered "a nuisance that affects public peace, safety and general welfare," and as such, can get a ticket.
- 3. Drive Through Red Lights: In 12 different states, a "Safe on Red" law allows riders to stop, and then go through red lights, in instances where light sensors don't detect the motorcycle.
- 4. ALWAYS Use Your Headlights: In Connecticut, motorcyclists must ride with their headlights on at ALL times, even during the day when the sun is shining. Visibility is always a good thing.
- 5. Don't Jump Off At 65 mph: In California, it's illegal to jump off your bike at speeds ABOVE 65 mph. No speed seems safe for this, but at least they're specific!


- 6. No Cursing: In Maryland, there's a law against cursing while driving. Without the protection of a car to muffle their expletives, riders have to keep their frustrations to themselves.
  - 7. No Hunting on a Motorcycle (except for whales): In Tennessee, don't get caught hunting from a moving motorcycle unless it's for a whale that's fine.
  - 8. Don't Carry Anything That Prevents Access to Handlebars: This is a smart law found in many states, which is often ignored. Neither groceries nor pets should ever obstruct your movement while riding.
  - Student Riders Must Wear Pants: In Minnesota, students in motorcycle endorsement courses must wear pants (as well as other protective outerwear).
  - 10. No Wheelies Allowed: In Maine (and other places), it's illegal to intentionally raise the wheel of a motorcycle from the surface of the road. Not a fun law, but for safety's sake, probably a smart one.
