## CASE RESULTS

### Attorney Jason Abraham Obtains \$1.35 Million – Insurance Company Offered \$700,000

Our client was stopped at an intersection behind a semi waiting to make a left turn. He was suddenly rear-ended by another semi with a force strong enough to crush the SUV he was driving into the semitrailer in front of him. Luckily his SUV popped out from between the two semis, but it careened into another passing car. Attorney Jason Abraham was able to settle the case for \$1.35 million after an original offer of \$700,000 was made.

### \$85,000 in Illinois Case Declined by Another Lawyer and Denied by Insurance

A Boone County, Illinois, resident and member of the armed forces stopped to render aid at an accident scene. As he was crossing the street, he was struck by a gawking motorist. Another lawyer declined to represent him. The insurance company said he was mostly at fault due to not crossing at a crosswalk and wearing dark clothing. Attorney Vito Manicioto took the case, threatened suit, and settled for \$85,000.

American health care is in love with prescription drugs. Spending has leapfrogged every year from under \$50 billion in 1990 to more than \$300 billion in 2010. - **FDA:** The Food and Drug Administration – the nation's watchdog on drug safety – suffers from serious scientific deficiencies and is not properly positioned to meet emerging regulatory responsibility.
- **Profits over Patients:** Pharmaceutical companies paid \$7 billion in fines for illegally promoting certain drugs during just the past five years.
- **Dollars for Docs:** Evidence documents drug companies providing payment to doctors for promoting targeted products.
- **Errors:** Occurrences of prescription transcription mistakes and pharmaceutical inaccuracy put patient safety at risk.
- **Unregulated Foreign Drugs:** With the increasing price of prescription medications, consumers are ordering medications online.

#### *What You Can Do To Minimize Risk*

- **Weigh Your Options:** Analyze treatment benefits compared with potential side effects.
- **Ask Questions:** Investigate new products and ask about alternatives.
- **Find Trusted Sources:** Compare what you are told and what you find online – making sure online data is not sponsored by a pharmaceutical company.
- **Be Skeptical:** Highly advertised drugs may be more about sales than effectiveness.
- **Read Labels:** Know the names of your prescriptions, dosages and treatment schedule.


