Hupy and Abraham, S.C. Recovers \$650,000 after **Client Blamed for Accident**

Hupy and Abraham, S.C.'s client was riding his motorcycle on a one-way street when a car pulled out from a stop sign and hit him. He suffered a serious head injury and can't remember anything about the accident.

The insurance company blamed our client for the accident and made no offer. Attorney Todd Korb filed suit and rejected a \$400,000 offer at mediation. Before going to trial, Attorney Korb secured \$650,000.

No Lawsuit Needed for \$500,000 Settlement

On a clear summer day, Hupy and Abraham, S.C.'s client was driving in lowa when a negligent driver tried to rush through a yellow light. The other driver turned left in front of our client, who was going straight and had the right of way.

Our client began experiencing neck pain and headaches, which required surgery. The insurance company argued the neck condition was pre-existing, but Hupy and Abraham, S.C. still recovered \$500,000 without going to court.

Client Recovers \$170,000 in Less Than Eight Months

Hupy and Abraham, S.C.'s client was taking Highway 30 from Fort Dodge to Cedar Rapids, Iowa, when someone ran a stop sign and caused a collision. Our client ended up in a ditch and sustained fractured ribs and a fractured hip.

The insurance company tried to settle the matter with several lowball offers. Attorney Brandon Derry refused to accept the offers and secured \$170,000 less than eight months after the accident.
