### After Insurance Company Denies Claim, Hupy and Abraham, S.C. Gets \$250,000

Hupy and Abraham, S.C.'s client was riding his motorcycle in Eldorado, Wis., when he came to a complete stop at a stop sign. As he accelerated through the intersection, the driver of an oncoming truck didn't see him and caused a collision, ejecting him from his bike.

### Protecting the Most Precious Pedestrians: Our Children


Hupy and Abraham, S.C. has always been passionate about pedestrian safety and awareness. When the sun comes out for the summer months, pedestrians also come out in droves.


