\$3,100,000 Settlement After Insurance Company Blamed Our Client

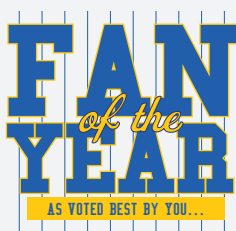

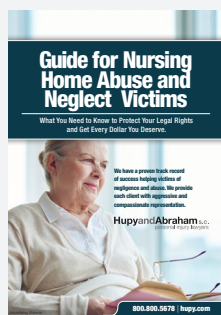

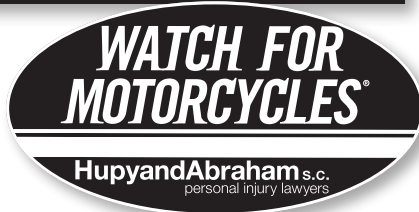
